All Men Play Party (A.M.P.P.) Liability Release & Event Rules

Liability Release

You must accept and agree to be bound by this **ENTIRE** Liability Release to be admitted to the event.

Express Assumption of Risk, Waver of Liability and Binding Arbitration Agreement: The undersigned, having read and understood this document and all its parts, freely and knowingly consents to its provisions.

<u>Named Parties</u>: For the purposes of this document representatives, employees and designees All Men Play Party (AMPP), their Owners, Representatives, Employees and Designees will collectively be referred to as "Hosts".

Disclosure of Risk: I am aware that the nature, purpose and activities provided by the Hosts may involve activities relating to BDSM acts and or sexual acts between adults. I acknowledge that those activities potentially may involve risks and dangers. I am entering the Hosts' events and engaging with full knowledge and appreciation of the potential for risk and dangers inherent in these activities.

Assumption of Risk: As consideration for being allowed to participate in the Hosts' events, I knowingly agree to voluntarily assume any and all risks of damage, liability or physical or emotional injury which may arise directly or indirectly out of the aforementioned activities, including but not limited to failure or breakage of equipment and/or damage or injury inflicted deliberately or accidently to me or by me as a part of any activity or conduct occurring at these events.

Waiver of Liability: As consideration for being allowed to participate in the Hosts' events, I hereby waive, release and hold harmless Hosts, their directors, officers and other members from and against any and all injuries, damages, cost, expense and liabilities in respect to emotional injury, bodily injury, death or property damage arising directly or indirectly from my attendance at or participation in these events. Further, I agree to indemnify Hosts from all claims or damages resulting from my behavior or attendance at Hosts' events.

Agreement to Arbitrate Disputes: As further consideration for being allowed to participate in the Hosts' events, I hereby agree that any and all disputes which may arise between me and the Hosts or any of their directors, officers and other members arising from participation in these events will be submitted to binding arbitration before and under the rules of American Arbitration Association. I will pay the full cost of any and all arbitration. I agree to be bound fully by the decision of such arbiter in lieu of a jury or court trial.

Binding on Heirs & Assigns: This agreement is binding upon me, my heirs and assigns, estate, and all other persons who may claim by or though me in the event of my injury or death.

Event Rules

You must accept and agree to <u>ALL</u> of these event rules to be admitted to the event.

- 1. <u>Loitering</u>: No one may loiter outside the event for any reason. In particular, men may not loiter outside the event location.
- **2.** Restrooms: There is no play activities in or around the restrooms.
- Cleanliness: I am responsible for cleaning up after myself and making sure that all materials are placed in the trash cans provided by Hosts.
- 4. <u>Consensual</u>: All activities must be agreed upon in advance by all parties involved, all participants are consenting adults. I will respect as a final the decision of anyone not to participate in an activity.
- 5. <u>Confidentiality</u>: All information about the identities and activities of Hosts', members and guests are held in the strict confidence by all members and guests, including telephone numbers, addresses, and any other personal information.
- 6. <u>Drug and Alcohol Rules</u>: No alcohol or Illegal drugs are allowed at any of Hosts' events, anyone found in the possession of illegal drugs or intoxicated at any function will be ask to leave, and membership will be revoked.
- 7. Sex and Nudity: Sex and nudity are permitted in the club.
- **8.** Safety: All activities must be performed in a safe and sane fashion. In this respect, the decision of Hosts directors and appointed representatives is final.
- 9. No Commercial Solicitation: No member or guest may offer or request any sexual or other services for money, property, or anything of value at Hosts' events. Any member aware of such activities must bring them to the attention of Hosts, Director immediately.
- **10.** <u>Cameras or Recording Devices:</u> At NO time may cameras or any other recording device is brought or used at Hosts event.
- 11. Age of Consent: I am 18 years of age or over, and I have read, understood and agreed to these rules and conditions of my attendance and participation at Hosts' events. I understand that if these rules are violated I may be asked to leave the event.
- 12. Refunds: There are no Refunds.
- 13. Email's: You agree to having emails sent to you, regarding AMPP information, with future party information.
